- iii. Building Improvement - workers are power washing building, replacing wood, prior to painting front of school.
- iv. Aerobic Septic System: Materials estimated at \$30,000. Labor probably almost that. We currently spend \$15,000 a year to have tanks pumped. Estimate for aerobic system is much higher than originally thought.
- v. We had gym floor and cafeteria floors done over Thanksgiving, and have cut back on outside use of our facilities.
- vi. Bus 14 is in shop. Maintenance Director is shifting buses around to make things work.
- vii. I am truly proud of every grade level. So happy with what is taking place academically this year. Kids are learning.
- viii. Doing fun things and learning. Good balance of fun and focus on learning. Benchmarking is in January. I will share data in February. In January, we will share data of growth first semester. I think we are going to see growth.
